6. Applications for Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Tuesday 25 April 2023.
7. Applications, amendments or cancellations of postal and postal proxy votes must reach the Electoral Registration Officer by 5pm on 18 April 2023.
8. Applications to vote by proxy at this election must reach the Electoral Registration Officer by 5pm on 25 April 2023.
9. Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer by 5pm on 4 May 2023.
